

  - peer & recovery support specialists
    - <u>48 state reimburse in Medicaid</u> (38 for mental health and substance use)



## Managed Care Approaches: Linking Payment to Performance

- Most states factor plan performance on at least on BH measure into MCO payment and into Prepaid Inpatient Health Plans
- Payment Approaches:
  - Incentive payments funded by capitation withhold
  - Leveraging Medical Loss Ratio
  - Value based payment
